## ORDINANCE NO. 2017-8

## ORDINANCE REVISING ORDINANCES 2011-7, 2014-7 AND 2015-4 MOTOR VEHICLE COUNTY EXCISE AND WHEEL TAX

WHEREAS, Indiana Code 6-3.5-5 authorizes Fountain County to collect a Wheel Tax on buses, recreational vehicles, semitrailers, tractors, trailers, and trucks; and

WHEREAS, Indiana Code 6.3.5-5-2(b) requires the passing of an Ordinance under 6-3.5-4, to impose the annual vehicle license County Excise Tax at the same time as the Wheel Tax is amended; and

**WHEREAS**, The Common Council of Fountain County previously stablished rates for an Excise Surtax and Wheel Tax by Ordinance 2011-6 on the `6<sup>th</sup> day of May, 2011, and, by Ordinance 2014-7 on December 22, 2014, and,

WHEREAS, the Indiana Legislature, in HEA 1087 (2016), revised the weight class tax structure schedule and renamed "county surtax" to "county excise tax", which requires existing ordinances to be amended to reflect the new weight class tax structure schedule and tax designation;

**NOW THEREFORE, BE IT ORDAINED** by the Common Council of Fountain County, that Ordinance 2015-4 be amended by incorporating the revised weight class tax structure schedule and change in tax designation passed in the 2016 Indiana Legislature session as follows:

Section 1. There is hereby established a rate for a Wheel Tax, said rates shall be as follows: (SEE ATTACHED RATE SCHEDULE)

Section 2. All prior Ordinances and Schedules previously adopted on May 16, 2011, December 22, 2014, and June 22, 2015, not inconsistent with the above amendments are incorporated into this Ordinance.

Section 3. The County Excise Tax shall remain as previously determined by the Common Council of Fountain County.
