

ORDINANCE 2015-4

**AN ORDINANCE AMENDING
ORDINANCES 2011-6 AND 2014-7**

MOTOR VEHICLE EXCISE SURTAX AND WHEEL TAX

WHEREAS, IC 6-3.5-5 AUTHORIZES Fountain County to collect a Wheel Tax on buses, recreational vehicles, semitrailers, tractors, trailers, and trucks; and,

WHEREAS, IC 6-3.5-5-2(b) requires the passing of an Ordinance under 6-3.5-4, to impose the annual vehicle license surtax at the same time as the Wheel Tax is amended; and,

WHEREAS, the Common Council of Fountain County previously established rates for an Excise Surtax and Wheel Tax by Ordinance 2011-6 on the 16th day of May, 2011, and, by Ordinance 2014-7 on December 22, 2014, and,

WHEREAS, the Common Council of Fountain County desires to amend the rates for the Wheel Tax, and within the same Ordinance impose the annual license surtax; and,

NOW, THEREFORE, BE IT ORDAINED by the Common Council of Fountain County, Indiana as follows:

Section 1. There is hereby established an amended rate for a Wheel Tax, said rates shall be as follows:


