

ORDINANCE 2014 - 7

AN ORDINANCE AMENDED ORDINANCE 2011-6
AND AMENDING FOUNTAIN COUNTY'S
MOTOR VEHICLE EXCISE SURTAX

WHEREAS, IC 6-3.5-4-2 Version b, Sec.2, Subsection (b), to become effective January 1, 2015 AUTHORIZES Fountain County to collect a Surtax on Motor Driven Cycles with a declared gross weight of not more than Eleven Thousand (11,000) pounds, and,

WHEREAS, the Common Council of Fountain County previously established rates for an Excise Surtax and Wheel Tax by Ordinance 2011-6 on May 16, 2011, and,

WHEREAS, the Common Council of Fountain County desires to amend the rates for the Excise Surtax but not for the Wheel Tax,


NOW, THEREFORE, BE IT ORDAINED by the Common Council of Fountain County, Indiana as follows:

Section 1. There is hereby established an amended rate for an Excise Surtax for passenger vehicles, motorcycles and trucks with the declared weight of not more than eleven thousand (11,000) pounds, said rates as follows:

(4) Motor Driven Cycles\$25.00

Section 2. All prior Ordinances and Schedules previously adopted on May 16, 2011 by Ordinance 2011-6, not inconsistent with the above amendments are incorporated into this Ordinance.

This Ordinance is hereby adopted by the Common Council of Fountain County, after its publication as required by law, this 22nd day of December, 2014
